- 1. Dean Boggs welcomed the group and introductions were shared around the table
- 2. AVC Forbes Berthoud detailed progress on revitalization of the Principles of Community
 - a. Created survey for leaders to share with constituent groups about what resonates / what needs improvement received 500 responses
 - b. Representation: Staff, Faculty, Graduate students, Undergraduate students, Alumni, Other
 - c. Top 5 constituent groups: Health Sciences, EDI, Staff Association, GSA, Student Affairs
 - d. Currently closed, will be reopened for Advocates and Influencers
 - e. Top Themes for: "Resonate"
 - i. Civility/Decency
 - ii. Freedom of Speech
 - iii. Right to Dignity
 - iv. Reject Acts of Discrimination
 - v. Acknowledge societal biases

Freedom of Speech was discussed.

- care should be taken not to limit freedom of speech in ways that cause others to feel limited
- possible to set stricter limits on members of university than members of society at large?
- as members of a research institution, we in some ways enjoy more freedom and in other ways less
- administration grapples with the Freedom of Speech question also: higher expectations for faculty and staff than we would for a person on the street, but setting standards for students and TAs may create a gray area
- f. Top Themes for: "Need Improvement/Update"
 - i. Change to nonbinary language
 - ii. Strengthen enforcement language
 - iii. Promote POCs better
 - 1. Create urgency
 - 2. Socialize
 - iv. Expand Descriptors (to include SES and Vet status, for example)
 - v. Shorten document or create a separate "Core tenets" document
- 3. Next Steps
 - a. Advocates and Influencers meeting usually 80-120 attendees. Will aim for 1500 responses
 - b. Mapping POC to policy share and collaborate with campus partners
 - c. Update
- 4. VC Petitt introduced Amber Vlasnik, Co-Chair of the Chancellor's Advisory Committee on the Status of Women.
